

Introduction

Our firm, Investment Insight Wealth Management, LLC, is an investment adviser registered with the Securities and Exchange Commission. We feel that it is important for you to understand how advisory and brokerage services and fees differ in order to determine which type of account is right for you. There are free and simple tools available to research firms and financial professionals at www.investor.gov/CRS, which also provides educational materials about investment advisers, broker-dealers, and investing.

What investment services and advice can you provide me?

We are a registered investment adviser that offers investment advisory services, including Investment Management and Comprehensive Financial Planning, to clients. If you open an advisory account as an Investment Management client with our firm, we'll meet with you to understand your current financial situation, existing resources, objectives, and risk tolerance. Based on what we learn, we'll recommend a portfolio of investments that is monitored at least quarterly, and if necessary, rebalanced to meet your changing needs and goals. We'll offer you advice on a regular basis and contact you at least annually to discuss your portfolio.

We manage accounts on a discretionary basis for Investment Management clients. After you sign an agreement with our firm, we're allowed to buy and sell investments in your account without asking you in advance. Any limitations will be described in the signed advisory agreement. We will have discretion until the advisory agreement is terminated by you or our firm.

We do not restrict our advice to limited types of products or investments.

Our account requirements are negotiable. We typically require a minimum household account balance of \$500,000 and an annual minimum fee of \$6,250 for our Investment Management service. We generally charge a minimum fee of \$3,750 for Comprehensive Financial Planning service. Comprehensive Financial Planning is typically included in our Investment Management service for no additional fee. Comprehensive Financial Planning is also offered as a separate service. We do not monitor your investments for the Comprehensive Financial Planning service.

What fees will I pay?

You will be charged an ongoing quarterly fee based on the value of the assets in your account. Our Investment Management's current tiered fee schedule ranges up to 1.25% depending on the value of the assets in your account. The more assets you have in your advisory account, the more you will pay us. We therefore have an incentive to increase the assets in your advisory account in order to increase our fees. Our fees vary and are negotiable. The amount you pay will depend, for example, on the services you receive and the amount of assets in your account. Our firm's fees will be automatically deducted from your advisory account, which will reduce the value of your advisory account.

We charge a flat fee based on 1.5% of annual household income for our Comprehensive Financial Planning service. If the annual household income-based fee is less than \$3,750, our firm will charge a fee of \$3,750. We charge an upfront retainer when you sign an agreement for this service or charge you when we provide a financial plan or consultation.

Depending on the investment type, the custodian that holds your assets charges you a transaction fee when we buy or sell an investment for you. Our custodian eliminated transaction fees for U.S. equities and exchange

traded funds. The custodian's transaction fees are in addition to our firm's fees for our Investment Management service.

You may also pay charges imposed by the custodian holding your accounts for certain investments and maintaining your account. Some investments, such as mutual funds, and exchange traded funds, charge additional fees that will reduce the value of your investments over time. You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

Questions to Ask Us:

- Help me understand how these fees and costs may affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs and how much will be invested for me?

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice, we provide you. Here are some examples to help you understand what this means:

Our firm's financial professionals include licensed insurance agents who sell insurance products for a commission. They have an incentive to recommend insurance products to you in order to increase their compensation.

Do you or your financial professionals have legal or disciplinary history?
